



GENERAL

Stamford Hotels and Resorts reserves the right to change modify or amend membership benefits, participating hotels and restaurant listings and these terms and conditions at its absolute discretion from time to time, with out giving a reason and without notice.

ACCOMMODATION BENEFITS

Special accommodation rates are available to members at participating Stamford Hotels and Resorts. Accommodation is subject to availability and as such prior reservations are essential. When making reservations, identify yourself as a SENATORS CLUB member. Your card must be presented to the hotel at time of check-in. During times of high occupancy or high demand a minimum number of nights stay may be required in order to enjoy the special membership rates. SENATORS CLUB members or Supplementary card members must be present as a guest to receive accommodation benefits. Room rates & accommodation packages offered to the public may be available to SENATORS CLUB members at a discount of 10% (unless otherwise stated in the terms and conditions for that rate). Late checkout of 2pm is subject to availability at time of stay. Airline Frequent Flyer points will not be rewarded when using vouchers and may not be available on some rates.

ACCOMMODATION VOUCHERS

Complimentary and \$50 discount vouchers are subject to availability due to a limited allocation of rooms. Rooms in excess of this allocation may be made available to voucher holders and is subject to the discretion of Stamford Hotels and Resorts. As room allocations fill quickly during peak periods or during periods of high demand including special events, school holidays and public holidays it cannot be guaranteed that a requested room will be available. Reservations are essential and are to be made direct with the hotel. At the time of making a reservation identify yourself as a SENATORS CLUB member wanting to redeem a voucher, quote your membership number and voucher number. Vouchers must be presented with your card at the time of check-in. One voucher (only) may be used per night of any stay. Vouchers cannot be applied to stays where the Senators Club 10% discount has been applied. Vouchers are valid for twelve (12) months only from the date of issue when your membership commences and cannot be extended.

Vouchers are the responsibility of the member and lost, stolen or damaged vouchers cannot be replaced.

DINING

The dining benefits are available at participating STAMFORD HOTELS AND RESORTS on presentation of the membership card. The membership benefits are not valid for room service, mini bar, bottle shop sales or children's menus. Some restaurants may not be open for lunch or dinner or may be hired for a private function. Please check with the hotel prior to dining.

BREAKFAST, LUNCH AND DINNER A-LA-CARTE

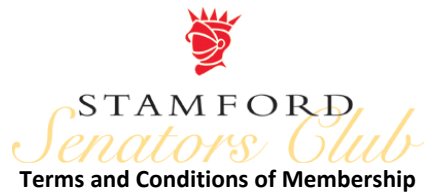

OTHER ITEMS

MEMBERSHIP CARD

The SENATORS CLUB card is property of STAMFORD HOTELS AND RESORTS. The privileges of membership will only be granted upon presentation of a valid membership card. The card must bear the signature of the member. The membership card is valid until the expiry date embossed on the card. Member may add one Supplementary Card to their membership at an additional cost of \$80. Supplementary cardholder must reside at the same principal address as member and be a spouse or partner of the member.

Use of the SENATORS CLUB membership card or membership privileges constitutes acceptance of these terms and conditions.

LOST OR STOLEN CARDS OR VOUCHERS
